



# The Gut Lab™ – Terms & Conditions

These Terms & Conditions (the “Terms”) govern your use of thegutlab.org and the associated web application and digital content (collectively, the “software”) operated by Omni Business Enterprises LLC (doing business as “The Gut Lab™,” “we,” “us,” or “our”). By purchasing, accessing, or using the software, you agree to these Terms.

## 1. Educational Use Only

The software provides educational content and self-guided journaling tools for informational purposes only. The software does not provide medical advice, diagnosis, prescriptions, or treatment. Purchasing or using the software does not create a clinician–patient relationship.

## 2. Eligibility

You must be at least 18 years old and able to form a binding contract to purchase or use the software.

## 3. Account Access

Access requires creating an account and signing in. You are responsible for maintaining the confidentiality of your login credentials and for all activity under your account. Sharing access is prohibited.

## 4. Subscription, Billing, and Cancellation

The software is offered as a monthly subscription (currently \$15.99 per month, plus applicable taxes where required). Your subscription automatically renews each month unless you cancel. You may cancel at any time prior to your next billing date; access will continue through the end of the current paid billing period. We do not provide prorated refunds for partial billing periods.

### 4.1 Payment Method Updates

Payments are processed securely through our third-party payment processor, Stripe.

Customers are responsible for keeping their payment information up to date.

When needed, payment methods may be updated through a Stripe-hosted customer page linked from billing emails or account notifications.

Failure to maintain valid payment information may result in interrupted or suspended access.

## 5. Refund Policy (7 Days; Limited Use)

Refund requests must be submitted within 7 calendar days of the initial purchase. Refunds are not available if “Substantial Access” has occurred.

Substantial Access includes any of the following (measured by account usage logs and/or the software's technical counters):

Viewing 5 or more educational modules/pages, Creating 3 or more journal entries, Generating or exporting 1 or more PDF summaries, 60 minutes or more total in-app time.

If you believe a charge was made in error, contact us before filing a chargeback. Unresolved chargebacks may result in account suspension.

## **6. Data Storage and Portability**

Journal entries are stored locally in your browser/device storage. We do not receive or store your journal entry content. Your entries will remain on that device/browser unless you clear your browser/site data, use private/incognito mode, or switch devices/browsers. We recommend exporting PDFs for your own backup.

We may store limited account and transaction data (e.g., email address, subscription status) to provide access. See the Privacy Policy for details.

## **7. Acceptable Use**

You agree not to: (a) copy, scrape, or redistribute content; (b) reverse engineer the software; (c) share logins; (d) use the software in a manner that violates law; (e) upload malicious code or attempt unauthorized access.

## **8. Intellectual Property**

All content, trademarks, designs, and software are owned by The Gut Lab™ or its licensors and are protected by applicable intellectual property laws. You receive a limited, non-transferable, revocable license to access the software for personal, non-commercial use during an active subscription.
